

ProLiteracy and the Florida Literacy Coalition (FLC), are seeking proposals for a pilot project on community collaborations between Adult Education/Literacy programs and local certified domestic violence centers. The objective of the pilot project is to transition survivors of domestic violence to traditional adult education/literacy programs when applicable and track their progress once in the traditional program. ProLiteracy and project partner the Florida Coalition Against Domestic Violence (FCADV) have been working on a state-wide initiative since 2016 to set-up small literacy programs in local certified domestic violence centers. These programs are currently operating in 29 of 42 centers across the state.

Successful applicants will:

- Provide a clear description of how their program will partner with a local certified domestic violence center that serves their community
- Estimate the number of survivors of domestic violence the partnership will serve
- Outline how objectives and outcomes of the proposed project will be measured.

Please note in order to apply for this mini-grant your organization must have a local certified domestic violence partner, and the lead fiscal agent and lead for the mini-grant must be the Adult Education/ Literacy Program.

The project period will run from May 15, 2019- February 1, 2020

**A character limit of 3400 words is approximately one page of text.

Requests for proposals are due April 19, 2019
