## Blue Cross and Blue Shield of Florida and the Florida Literacy Coalition Award Health Literacy Grants

ORLANDO, Florida (May 21, 2010) - Sixteen Florida adult ESOL (English for Speakers of Other Languages) and family literacy programs were recently awarded one-year grants of \$5,000 each. The funds will be used to establish a network of health literacy projects providing adult students with important information about health and nutrition while learning English.

The Florida Health Literacy Grant Initiative, funded by <u>Blue Cross and Blue Shield of Florida</u> (BCBSF), and operated by the <u>Florida Literacy Coalition</u> (FLC), is a three-year project committing \$360,000 to improving the health literacy level of Florida residents by supporting literacy programs with financial and technical support. As part of the initiative, the FLC provides grantees with training opportunities, inter-agency collaboration facilitation and resource forums to build upon the strengths of each individual program.

There is growing consensus among health care providers and adult educators nationwide that limited English language and literacy skills can have a significant impact on one's health. According to the National Center for Education Statistics, 14 percent of American adults have below basic health literacy skills. Adults with low health literacy skills cost the industry an estimated \$73 billion annually in the form of longer hospital stays and increased emergency room visits, doctor visits and medication.

"At BCBSF, we are committed to helping people and communities achieve better health," said Susan Towler, executive director, Community Affairs, BCBSF. "By partnering with the Florida Literacy Coalition and supporting the Florida Health Literacy Grant Initiative, we are reaching more and more Floridians every day and positively impacting their health and well-being."

In 2009, BCBSF and FLC awarded health literacy mini-grants to ten organizations. This year's funding reflects a combination of new grants and renewal grants, allowing current programs to continue and build upon their ongoing efforts.

"This initiative reflects Blue Cross and Blue Shield of Florida's outstanding commitment to helping adult learners develop the skills they need to be informed health advocates for themselves and their children," said Greg Smith, executive director of FLC. "We have already seen significant results in students becoming more health literate and we really appreciate BCBSF for making it all possible."
