LITERACY AND THE HOMELESS

Homelessness literally means 'Without a Home' yet this definition may not include those persons who live in small quarters with relatives or friends, those who face frequent evictions, or those who are just a paycheck away from homelessness.

In Florida, approximately 76,675 people are homeless. This is a 17% increase from 2000 to 2002/2003. Of that, 40% of the homeless population is families, and 35% are children. Eight percent are over 60 years old. Eighty-four percent are headed by a single mother. Forty-three percent have never been homeless before, thirty-nine percent are employed, and eighteen percent are employed full time.

In 2004, the number of request for shelter by homeless families increased an average of 7% and 32% of families seeking shelter could not find it.

Children who are homeless are one of the growing segments of the general homeless population. When children become homeless, they face educational setbacks. Requirements of the legal guardianship, lack of a permanent address, and immunization records often delay or prevent homeless children from enrolling in schools and receiving an adequate education. Without a chance to get an education, children who are homeless are often unable to acquire the necessary skills they will need to escape from the poverty that led them to become homeless in the first place.

The profile of Florida homeless has shifted. Although single adult males make up 41% of the total homeless population, families and children continue to be a growing segment of the homeless in Florida. Families now make up 40% of all homeless persons. Children under 18 years of age comprise over 35% of all homeless persons.
